



MEMBERSHIP OF THE STEWARDS' ENCLOSURE

The Committee of Management considers it necessary, in a determined effort to safeguard the ambience of the Enclosure and secure the comfort of those attending the Regatta, to limit the total number of Members.

Candidates are therefore placed on a waiting list and preference is given to those who have competed at the Regatta, or have some particular connection with the Regatta or have a close involvement with the sport of rowing. Candidates who compete at the Regatta for the first time while on the waiting list should write to the Chairman giving details.

The waiting list now comprises around 1,000 candidates and those who have rowed at Henley Royal Regatta are currently experiencing a wait of about five to six years. Candidates who have not rowed at the Regatta can currently expect to wait about seven to eight years.

On receipt of a candidate's completed application, the Regatta Office will contact the candidate giving details for paying the Entrance Fee by bank transfer - £25.00 for those who have rowed at Henley Royal Regatta (excluding the Qualifying Races) and £75.00 for all other candidates. **Candidates will NOT be added to the waiting list until the Entrance Fee has been received by Henley Royal Regatta.**

Candidates should receive a postcard acknowledgement, with a unique reference number, once the application process has been completed and their name has been added to the waiting list.

RULES OF MEMBERSHIP OF THE STEWARDS' ENCLOSURE

Introduction

The Stewards' Enclosure is for Members and their Guests, to enable those who have competed in the Regatta in the past, or who have a connection with or interest in the Regatta and the sport of rowing, to attend the Regatta in comfortable surroundings. The facilities of the Enclosure are for the use of Members to invite their families and friends as Guests, and not for the purpose of commercial gain or benefit.

Rules

1. Candidates must be proposed and seconded by two Members on the standard form. Applications cannot be accepted from candidates under the age of 18 years unless such a candidate has already competed at Henley Royal Regatta. Applications should be accompanied by a detailed letter from the proposer or seconder setting out the candidate's connection with the Regatta or involvement with the sport of rowing, and suitability for Membership.

2. Applications should also be supported by the appropriate Entrance Fee, which is non-refundable. There shall be a concessionary rate in the case of Candidates for Membership who have actually competed at the Regatta (excluding Qualifying Races) and a full rate for other Candidates. The concessionary rate is available only once to a former competitor; that is to say, a former competitor who has allowed his Membership to lapse will be obliged to pay the full rate of Entrance Fee upon re-application.

3. Members shall be responsible for their Guests. Guest Badges, whether arising from a Member's allocation or separately purchased, are not to be disposed of for the purpose of commercial gain or benefit whether by a Member or by a third party. A Member will be struck off the List of Members and will cease to enjoy the benefits of Membership forthwith if it is found that any of that Member's Guest Badges have been disposed of or offered for commercial gain or benefit. For the avoidance of doubt, Members are reminded that the disposal or offer referred to above by a third party does not absolve the Member from responsibility.

4. In order to ensure that no unauthorised person uses the Enclosure, Members and their Guests, whilst they are in the Enclosure, shall wear their badges so that they are readily visible, and shall produce their badges upon request from any Steward or any Regatta official.

5. If a Member or a Member's Guest(s) exhibits conduct which the Committee, at its absolute discretion, deems inappropriate, unsporting or prejudicial to the interests of the Regatta, it may suspend or expel the Member and/or the Member's Guest(s) with immediate effect. The Committee may delegate its authority under this rule to the Secretary.

6. The amount of the Annual Subscription shall be determined by the Stewards. There shall be no refund of any part of the Annual Subscription notwithstanding the Regatta may be cancelled in whole or in part. A Member is entitled to a personal admission badge on each day of racing and additional admission badges for Guests under conditions decided annually by the Committee. The current scale of Subscription and entitlement to Guest Badges may be obtained from the Secretary. Additional Guest Badges may be obtained from the Secretary at such prices as the Committee of Management shall from time to time determine.

7. Subscriptions shall be paid by Direct Debit on or just after 1st January in each year and no refund of Subscription for the current year will be made unless written notice of resignation has been received by the Secretary before that date. No badge shall be issued until the Subscription has been paid. Any Member in arrears with his Subscription shall be liable to be struck off the List of Members at the discretion of the Stewards and any Member so struck off shall not be eligible to apply for re-election until after the expiration of three years. The liability of the Stewards for badges and other items sent to Members must necessarily be limited to such items being duly posted to the address notified by the Member. Failure by the postal service to deliver items correctly is a matter to be resolved between the Member and the postal authorities.

8. A Member who does not attend the Regatta is not entitled to any remission of Subscription, except that Members who are resident abroad for a continuous period of 12 months or more, including the week of Henley Royal Regatta, may, on application to the Secretary, be retained on the List of Members at a reduced Annual Subscription.

9. No one who has been a Member and had his Membership cancelled under the provisions of Rules 3 or 5 shall be allowed in the Enclosure.

10. The Stewards shall have absolute power to alter or add to the existing Rules.

11. Members shall have no voice in the management of the Regatta, but any suggestions put forward by Members regarding the Enclosure shall be given full consideration.

12. The Committee may in its absolute discretion elect persons as Honorary Members on such terms as it shall think fit.
